I further state that the Claimant made known to me his business training project "Tendering for Contracts" in 1997.

The Claimant explained that his new business venture "Tendering for Contracts" training workshop project was in the process of being piloted, the workshop was divided into (4) four sections - and as one of these sections included the area of my expertise - Quality Management Systems, the Claimant enquired if I would be interested in becoming a member of the delivery team when the project started.

In (1998) the Claimant explained that although he was trained in Quality Management Systems for a period of (6) months, he wanted the (4) sections of his "Tendering for Contracts" training project to be delivered by (4) specialist - who could then provide the additional high level of support to delegates who attended his training workshops.

He went on to request my participation as a presenter of the Quality Management section of his training project based on the payment of a nominal sum for my efforts -

I accepted the Claimant's proposal to join his team in 1998, and between (1998 and 2000) the delivery team consisting of the same (4) persons and headed by the Claimant conducted a series of (4) pilot workshops.

The location of these workshops were as follows;
 (2) workshops were conducted at the premises of Business Link London South West, -

(1) workshop was conducted under contract to Business Link London North West and


(1) workshop was conducted on behalf of the (SBL) - Society of Black Lawyers, in Central London

The average number of delegates at each workshop was approximately (20), the final workshop for the (SBL), the delegates numbered approximately (150).

He went on to request my participation as a presenter of the Marketing Products and Services section of his training project based on the payment of a nominal sum for my efforts -

I have known the the Claimant, Beauford Lloyd Sewell, in person since (1995), I first met the Claimant at a Thames Valley Small Business Network meeting where the Claimant had the position of Treasurer of the Thames Valley Small Business Club, I later became the Auditor of the Thames Valley Small Business Club. The Claimant informed me that he was in the process of starting his own business.

The Claimant explained his new business venture as a "Multimedia Business Training Centre" and in 1996, the Claimant requested my services as accountant to his firm and I accepted the task.

The Claimant's first business - (which was first registered in 21-May-1996), failed, because the required business support that the Claimant required - although promised by a government agency - never materialised - and the Claimant was forced to cease trading in 1997.

In (1998) the Claimant explained that his new business venture "Tendering for Contracts" training workshop project was in the pilot stage, that the workshop was divided into (4) four sections - and that he was hoping to conduct a number of workshops supported by his (3) associates a Business Link and a Local Authority in the London area.

The Claimant has had his "Tendering for Contracts" workshop training project endorsed (2002) by the "Small Firms Enterprise Development Initiative" (SFEDI) a government accreditation agency and I am one of the persons endorsed by the (SFEDI) to act as administrator to the Claimant's project.

Since (1998) the Claimant has sought the support various government funding agencies and local authorities for his "Tendering for Contracts" workshop training project with very limited success.

The Claimant has formed a refurbished grouping of his associates - in the hope of obtaining local authority contracts, unfortunately - the Defendants are also submitting tenders for the same contracts, I am a member of this new group, which numbers (5) persons in total.

My considered opinion relating to the Defendant's claim that they have the support of the Department of Trade and Industry, plus many other government agencies and local authorities - is that such support to the Defendant would be detrimental to the Claimant efforts and hence the Claimant has little chance of being successful in any of the areas in which the Defendants are also active - ie the London area as a whole.
