This letter confirms the statement made by Mr Lloyd Sewell, vis-à-vis that I was a party to discussions, which took place in March-1996, involving Mr John Murray, then Business Development Director of West London Training and Enterprise Council.

The meeting with Mr John Murray, was arranged by Lloyd Sewell and took place at London College of Further Education of 4 Clapham Common Northside, London SW4, a college providing vocational and academic educational courses to both UK and International students.

The contents of the meeting with Mr John Murray centered around his capacity as Business Development Director of West London TEC, in assisting our efforts in the setting up of a Business Training Centre using Multi-Media.


Mr Sewell reported to me on several occasions about his other discussions that took place with Mr John Murray about the progress of assistance from West London TEC on several occasions during the following months of 1996.

During the original discussions, Mr Murray always maintained that help was available and that he as Business Development Director and West London TEC would be instrumental in providing the help for this project.
